

**SCHOLARSHIP POLICY**

**RATIONALE**

Darul Ulum College of Victoria Scholarship Program aims to encourage and recognize students in their pursuit of excellence. The Scholarship Program at the College is intended to provide students with the financial support to further their education as well as reward achievement and effort.

**ELIGIBILITY CRITERIA**

1. All eligible students must be of Year 7 to Year 12 level.
2. Students who score an average of 70% or above based on semester one internal data will be shortlisted for further scholarship testing during semester 2.

**IMPLEMENTATION**

1. All applicants must full under the above mentioned eligibility criteria.
2. The scholarship entitles the holder to the remission (via exemption/subsidy) of tuition fees only, dependent on the category of scholarship. The entitlements are issued on a pro-rata basis. Scholarship recipients will receive their first instalment equating to 50% of the scholarship amount in Term 1, 25% of the amount in Term 2 and the remaining 25% in Term 3.
3. All scholarships are valid for one calendar year.
4. Scholarship recipients are only eligible to the benefits of the scholarship scheme while they remain enrolled.
5. The College Board of Darul Ulum College of Victoria offers annual scholarships to eligible students from Year 7 to Year 12.
6. Year 7 eligible students will be determined in light of their Grade 6 moderated results.

7. Students will only qualify for the scholarship program based on the results as per the discretion of the administration.
8. Scholarship benefits will be applied in the subsequent year to the year of testing.
9. The College will deal with the test results in a confidential manner. The College reserves the right to offer scholarships, review and/or amend the scholarship procedures and protocols as deemed appropriate.
10. Data used to determine qualifying students will be ready by early term 4 of each year.
11. Families with overdue fees/levies (current and previous) will be ineligible to redeem the
12. benefits of the scholarship entitlements.
13. Families who fail to pay their school fees by the due date will forfeit their scholarship entitlements.
14. Names of qualifying students will be advertised on an annual basis through various publications including the College newsletter and website.
15. Darul Ulum College reserves the right to make change, amend or cancel this scholarship scheme at the College's sole discretion without prior notice.
16. Parents who are not willing to participate in the scheme as per the outlined Policy must notify the College in advance.
17. Parents/guardians who opt to pay a lump sum annual school fee in advance have the option of either leaving the scholarship entitlement as credit in their school account or redeeming the entitlement through electronic transfer in Term 1.
18. Parents/guardians are not permitted to under pay a given school fee invoice in anticipation of qualifying for a scholarship.
